




#### Esri: 30-45-60 Minute Drive Time





#### 2022 Household Income











## Pearl River County Technology Park– Site Development 2023 Award


- Pearl River County pursued Site Development Funding with the Mississippi Development Authority to assist with completion of due diligence reporting and site clearing of approximately 10 acres.
  - Due Diligence Reporting Included:
  - Topographic Survey
  - ALTA Survey
  - Wetlands Delineation
  - Phase I Environmental Assessment
  - Cultural Resources Survey
  - Threatened and Endangered Species Survey
  - Total Site Development Project: \$100,000.00
  - \$50,000.00 MDA Site Development
  - \$25,000.00 County Match
  - \$25,000.00 Cooperative Competes Grant



## Pearl River County Technology Park-GCRF 2023 Award

- Pearl River County pursued Gulf Coast Restoration Funding (GCRF) during the 2023 Legislative Session for the construction of the 1<sup>st</sup> building on the master planned site.
  - Total GCRF Project: \$2,250,000.00
  - \$1,800,000.00 in GCRF Funding
  - \$450,000.00 in County Match
  - The County is in the process of completing all relative due diligence





## Pearl River County Technology Park– Site Development 2024 Award

- Pearl River County pursued Site Development Funding with the Mississippi Development Authority to assist with site grading and the initial construction of the road at the technology park property.
  - Aspects of the project include:
  - Site grading
  - Erosion Control
  - Granular material for the project
  - Asphalt paving
  - Curb and guttering
  - Striping
  - Total Site Development Project: \$100,000.00
  - \$50,000.00 MDA Site Development
  - \$25,000.00 County Match
  - \$25,000.00 Cooperative Competes Grant
